OBJECTIVE

The investment policy of the portfolio shall be to track the S&P South Africa Low Volatility Index as closely as possible, by buying only constituent securities in the same weightings in which they are included in the Index and selling only securities which are excluded from the Index from time to time as a result of quarterly Index reviews or corporate actions.

The index, which is constructed and maintained by S&P Dow Jones Indices, is designed to provide exposure to the least volatile stocks on the S&P South Africa Composite Index. Volatility is measured by using the one year trailing standard deviation. The 40 least volatile stocks passing the liquidity filter are selected and are then weighted by the inverse of their volatility i.e. the company with the lowest volatility has the highest weighting and the company with the highest relative volatility has the lowest weighting.

DIFFERENCE BETWEEN ETFs AND UNIT TRUSTS

ETFs and Unit Trusts are both CISCAs portfolios and therefore they are regulated by the Financial Services Board – however ETFs are listed on the JSE and are therefore also regulated by the JSE. ETFs and Unit Trusts may seem similar in nature as they both hold a basket of shares but there are many differences between the two.

The differences not only lie within the investment approach but also:

- Trading – ETFs are listed on the JSE
- Transparency – You know exactly what shares the ETF holds
- Fees and minimum investment differs between the funds
- ETFs take a passively managed approach whereas active Unit Trusts focus more on an active strategy

HOW TO INVEST (CORESHARES LOWVOLTRAX)

Coreshares LowVolTrax is listed on the JSE which means it can be bought or sold just like shares, throughout the day, through any authorised individual or any online platform. i.e Stock Brokers, Online Share Trading platforms and Investment Platforms such as etfSA and iTransact.

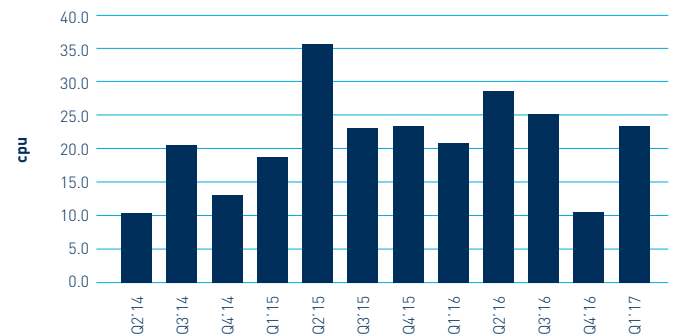

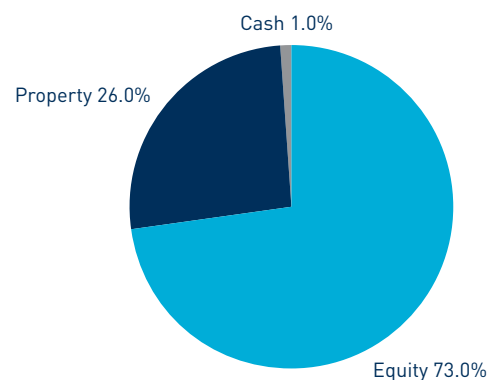

The portfolio may borrow up to 10% of its net assets on a temporary basis. Such borrowings are permitted only to meet the portfolio's obligations in relation to (i) the administration of the Fund relating to purchase or sale transactions; and/or (ii) the redemption or cancellation of participatory interests in the portfolio. Borrowings in relation to (i) above are only permitted for a period of up to 8 calendar days, and 61 calendar days in respect of (ii). Past portfolio performance is measured on a rolling monthly basis.
